The article deals with the impact of the phenomenon of globalization on the sphere of culture of today for middle-aged people. The aim was to outline the field of cultural transformations triggered by new civilization-globalization conditions, in particular: rapid development of information technologies, problems of communication and identification, erosion of national-traditional values in middle-aged people. On the basis of consideration of the analysis of globalization, as a socio-cultural phenomenon, the correlation of civilizational and cultural factors among the category of middle-aged people is revealed.

RESULTS OF THE RESEARCH AND DISCUSSION

The development of modern technologies has led to the increase of interaction in all spheres with cultural inclusive. The phenomenon of globalization is particularly evident in the category of middle-aged people. There are few works in which these processes and phenomena would be analyzed in the context of cultural analysis.

B. Adams, Sh. Eisenstadt, R. Robertson, M. Firestone, W. Gunners dedicated their attention to the cultural aspect of globalization. The authors of these studies have focused on identifying and exploring the multidirectional vectors of cultural development dynamics, the hybrid nature of cultural interaction [4].

CONCLUSIONS

Thus, for the formation of contemporary identities, in the middle-aged category, a new policy is needed that would work within the system of cultural values and behavioral models, capable of producing a new discourse of identity. During the time of Modernism, the process of imposing cultural patterns, practiced by the ruling strata, began as normative and the degradation of the status of popular culture to non-culture. Only on the basis of homogenization of the cultural space of individual states was it possible to transform them into modern ones. The formation of nations required cultural unification through the elimination of regional differences, the displacement of local traditions into the periphery of life, the invention of a "common denominator" of the variability of ethnic and traditional cultures.
